



## Dear Parent,

As part of Monmouth Comprehensive School's Summer Learning activities (16<sup>th</sup> – 18<sup>th</sup> July) Year 8 will be participating in a number of activities both in and out of school. Each form will spend one day away from school with the instructors from Gilwern Outdoor Centre; JG and SE will attend on Thursday. Students will take part in one of three activities, canoeing, climbing or caving, for the whole day. The instructors will be providing the transport, expertise and safety equipment for the day and will be accompanied by a member of MCS staff. Students should bring a packed lunch, water and suitable clothing, see the attached kit list for the day.

Students need to wear school PE kit throughout the three days, including appropriate footwear for each activity. Please also ensure they are prepared for the weather conditions, i.e. with a rain jacket, sunscreen, hat, and ample water. On the Gilwern Outdoor Centre Day students should follow the attached kit list. Unless advised by the activity leader, for off site visits students will leave on arranged transport after registration and return in time for home to school transport as normal.

In accordance with the School's Health & Safety procedure failure to give consent will result in your child not being able to take part in these activities. By law these are activities for which we are unable to make a charge. However, we are asking for a contribution of £25.00 towards the overall costs of the events.
